

Information for pet owners

The requirements for import/transport of pets into Norway have not been fulfilled at the time of border control. This document provides you with information on how to proceed.

The pet will be placed in temporary accommodation or quarantine at the owner's expense until the animal's health and/or ID requirements are met.

<u>Please keep in mind</u>: The stay must be paid in advance upon arrival or at the latest within one week, animals that are not paid will be humanely euthanized. Animals are not disclosed until the stay in its entirety is paid. By use of credit cards, a premium of 2% is added.

AirPet require all dogs in their care are vaccinated against parvovirus and kennel cough, cats must be vaccinated against cat flu. If immunizations are due during the quarantine period, the animals will be vaccinated at owners expenses.

The pet is isolated

If treatment against echinococcus (tapeworm) has not been given, or administered less than 24 hours and not more than 120 hours prior to arrival in Norway, the animal must be kept isolated at the owner's expense until such treatment can be administered and/or 24 hours has passed since the treatment was administered.

For other requirements not fulfilled (ID, passport, rabies vaccine) there will be other quarantine demands.

If the animal in isolation/quarantine need veterinary treatment, the quarantine veterinarian will be called at the owner's expense. The costs must be paid before delivery of the animal.

The pet will be returned to the country of origin (where the animal started its journey)

The owner must document how and when the return will take place e.g. by showing his/her ticket to the company (AirPet) responsible of transporting the animal to the chosen place of departure. The transport of the pet must be arranged/agreed with AirPet who will make sure the pet is handed over at time of departure. The pet will be kept at the owner's expense until the return of the animal is possible to implement.

The pet is to be euthanized. This will be done at the owner's expense.
