Special remarks

- (1) = Checking in line with the requirements of Commission Decision 93/352/EEC taken in execution of Article 19(3) of Council Directive 97/78/EC
- (2) = Packed products only
- (3) = Fishery products only
- (4) = Animal proteins only
- (5) = Wool hides and skins only
- (6) = Only liquid fats, oils, and fish oils
- (7) = Icelandic ponies (from April to October only)
- (8) = Equidae only
- (9) = Tropical fish only
- (10) = Only cats, dogs, rodents, lagomorphs, live fish, reptiles and other birds than ratites
- (11) = Only feedstuffs in bulk
- (12) = For (U) in the case of solipeds, only those consigned to a zoo; and for (O), only day old chicks, fish, dogs, cats, insects, or other animals consigned to a zoo
- (13) = Nagylak HU: This is a border inspection post (for products) and crossing point (for live animals) on the Hungarian-Romanian border, subject to transitional measures as negotiated and laid down in the Treaty of Accession for both products and live animals. - (14) = Designated for transit across the European Community for consignments of certain products of animal origin for human consumption, coming to or from Russia under the specific procedures foreseen in relevant Community legislation
