## V Health requirements/Zdravstveni zahtevi

I,/Ja, .....the undersigned official veterinarian of the----- herewith declare that the following consignment of bovine semen fulfills the following requirements/dole potpisani zvanični veterinar ----- ovim potvrđujem da navedena pošiljka semena bikova ispunjava sledeće zahteve:

1. the semen collection centre/AI station exporting the semen is under supervision of an official state veterinarian and is approved in accordance with Directive 88/407 EEC;/centar za prikupljanje semena/VO stanica izvoznica semena je pod nadzorom zvaničnog državnog veterinarara i odobrena je u saglasnosti sa Uputstvom 88/407 EEC
2. the semen originates from a collection centre/AI station that is free from diseases notifiable in the-----, in accordance with EC and national legislation;/seme potiče iz centra za prikupljanje /VO stanice koja je slobodna od bolesti obaveznih za prijavljivanje u -----i, u saglasnosti sa EZ i nacionalnom legislativom
3. in the -----the feeding of ruminants with meat-and-bone meal and greaves derived from ruminants has been banned and the ban has been effectively enforced;/u -----je zabranjena ishrana preživara mesno-koštanim brašnom i čvarcima i zabrana se efikasno sprovodi
4. in Norway no cases of Rinderpest, Contagious Bovine Pleuropneumonia, Foot and Mouth Disease, Vesicular Stomatitis and Peste des Petits Ruminants have been diagnosed during the last 12 months;/u Norveškoj nije bilo slučajeva kuge goveda, pleuropneumonije goveda, slinavke i šapa, vezikularnog stomatitisa i kuge malih preživara u poslednjih 12 meseci
5. in the exporting collection centre/AI station no clinical cases of Bovine Spongiform Encephalopathy, Paratuberculosis, Brucellosis, Tuberculosis, Enzootic Bovine Leucosis, Infectious Bovine Rhinotracheitis, Campylobacter Fetus Venerealis, Leptospirosis hardjo and Trichomonosis have been diagnosed during the last 12 months;/u izvoznom centru za prikupljanje /VO stanici klinički slučajevi BSE, paratuberkuloze, bruceloze, tuberkuloze, enzootske leukoze goveda, IBR-a, kampilobakterioze, leptospire hardjo i trihomonijaze nisu dijagnostikovani u poslednjih 12 meseci
6. the donor bulls of the exported semen have not been vaccinated against Brucellosis and Foot and Mouth Disease;/bikovi donori izvoznog semena nisu vakcinisani protiv bruceloze i slinavke i šapa
7. In the country of origin of semen there is no evidence of Bluetongue disease during the past twelve (12) months, or the donor animals were subjected to a serological test according to the Terrestrial Manual to detect antibodies to the BTV (Bluetongue virus) group, with negative results, at least every 60 days throughout the collection period and between 21 and 60 days after the final collection for this consignment;/U zemlji porekla semena poslednjih dvanaest (12) meseci nije bilo bolesti Plavog jezika \*: / ili su životinje donori bili podvrgnuti serološkom ispitivanju u skladu sa Priručnikom za kopnene životinje za detekciju virusa bolesti plavog jezika, sa negativnim rezultatom, najmanje svakih 60 dana tokom perioda prikupljanja i između 21 i 60 dana posle krajnjeg prikupljanja za ovu isporuku\*.
